a. Timeline review – CSIP and Land Trust Plans

- i. Are we on track to meet goals? Review school and grade level data
 - a. School Climate Survey
 - b. Updating the Mountaineer Market, possible mobile market
 - c. Math Inventory: 54% of MJMS students are *Basic, Proficient, or Advanced* based on winter scores
 - d. Reading Inventory: 52% of MJMS students are *Proficient or Advanced*
 - e. Discussion regarding sweatshirt incentive: Are we rewarding all achieving students appropriately? Cindy will take this conversation back to the BLT to discuss an adjustment, if warranted
- ii. Do we need an amendment?
 - a. Cindy believes we do not need an amendment. A math tutoring shift was made for how teachers are being paid.

- a. College & Career Readiness Meetings are beginning: ~30 minute meetings for students with parents/guardians, 4-year plan
 - i. Multiple forms of communication have and will be sent home to encourage parents/guardians to sign up for their choice appointment time

c. Cell tower money

- iii. Cindy requests ~\$2000-\$3000 be used as stipends for teachers who fulfill extra responsibilities
- iv. AVID is supplying funds to pay for 5 teachers in February and 5 more in summer to attend a training; hopefully no cell tower funds will be needed

d. 6th grade math

- i. Currently 3 of 8 CSD middle schools do not have 6th grade honors math classes
- ii. 6 of 8 will not next year
- iii. Demographics of honors classes do not reflect school demographics; desire to change that to reflect the AVID mission we embrace
- iv. Proposed curriculum change would enhance the rigor overall and have extensions built into the lesson planning that could be completed by individuals and small groups within a class
