- II. Adopt/Amend agenda
- III. Business items
 - a. Timeline review CSIP and Land Trust Plans
 - i. Are we on track to meet goals? Review school and grade level data
 - ii. CSIP Goals for next school year are very similar to current year. The BLT desired to keep our goals similar as they are still a need.
 - iii. Proposed CSIP Goal: At the end of each quarter during the 2018-19 school year,
 75% of MJMS students will be on track for graduation as evidenced by EWSI
 data including attendance, behavior, and coursework (no Ds, Fs).
 - a. Supports: Climb Time during lunch, 20 minutes of Friday meetings to increase parent communication, after school science and math intervention, after school support lab, AVID continues school-wide
 - b. LandTrust moneys for ASL, Tier 2 and 3 para support, AVID curriculum and materials, professional development
 - iv. We retained our FTE of 37

- v. Proposed CSIP Goal: After the spring 2018-19 Reading Inventory, 65% of MJMS student will score proficient or highly proficient on the Reading Inventory.
 - Supports: School-wide AVID and WICOR strategies with a focus on critical reading strategies, reading intervention classes, literacy strategies, student rewards for growth
 - b. Budget needs for AVID achiever program, AVID critical reading manuals
- vi. Proposed CSIP Goal: 70% of MJMS students will demonstrate proficiency on the Math Inventory with scores of basic, proficient, or advanced.
 - a. Supports: math interventions during the day, after school math lab, student motivation and rewards for ALEKS growth
 - b. Budget needed for ALEKS licences school-wide, math tutoring after school
- vii. Proposed CSIP Goal: During the 2018-19 school year, MJMS teachers will teach an AVID learning modules or Grit, Mindset, and Motivation lessons during their 30 minute new Mountaineer Time twice per month to increase student motivation/attitude/emotional well being.
 - Eric shared the plan for changing this time. He shared it with the BLT yesterday. No program or materials are being purchased. Faculty would be designing/planning the use of this time.
 - b. Budget needs for Mountaineer Market

 - a. Parent Teacher Conferences went well.

 Hoping to schedule assembly next year during digital citizenship week. Looking into live streaming/recording assembly next year for parents to watch.
 - d. Student vs Faculty PBIS Activity. Student Council's activities in between were fun.
 - e. Cindy wonders if moving the PBIS Activity to another time during the day to reduce the number of students who get checked out. She wishes there was a little more buy-in support for this motivator. Eric and Cindy acknowledged that they let too much time lapse between events.
- VI. Principals report
 - a. Walk Out. Over 600 students chose to walk out. The rain started during the event and so some students got a little antsy. Cindy had done an all-call announcement in the morning to establish the purpose for the event without any political discussion.
 - b. Report of 2017-2018 budget
 - c. Review CSIP/Land Trust registration process
 - LandTrust Amendment: Primarily because of changes to our paraprofessionals (the new folks are at a lower pay scale than we used to figure amounts and many have been absent), we have a larger overage than we anticipated. We

need to spend \$45-50,000. Mount Jordan would like to amend the LandTrust plan for this year to reflect the following needs:

- Mount Jordan would like to send 8 teachers to the AVID Summer Institute at the cost of \$2,000 per teacher. Total cost \$16,000
- iii. Mount Jordan would like to pay teachers for additional training in the implementation of new technology programs to benefit student learning. Total cost: \$15,000 at \$300 per teacher.
- iv. Mount Jordan would like pay teachers for developing additional lessons/activities related to AVID implementation school-wide and Co-Teaching for our SpEd classes. Total cost: \$15,000
- Robyn made a motion to amend the LandTrust. Beki seconded. All approved.
